He also informed the Board of the PAC committee's decision to reimburse the Local Operating Fund costs associated with the Legislative and Political Conference in Washington, DC.

- **A. Agency Fee/Objectors:** The Board reviewed the total funds returned to the National for Objectors.
- **B.** The Board reviewed the outstanding list of AT&T, employees that need to be signed up. AT&T list has been reduced drastically in the Eastern Region. The Executive Board addressed concerns regarding sign-ups in Units 42 & 43. The Board will attempt to use Verizon Unit President's in the west and AT&T Representatives in adjacent areas from the Eastern Units to accomplish signing up new members.
- **C. Verizon EISP:** The union is waiting for Verizon's report of individuals who accepted the EISP offer. The union questioned the company's offer and identified some locations that were omitted in error. Verizon issued a new report to include those locations in a new report. All other locations that were questioned were intentionally left out.

#### 6. District 2-13:

- **A.** Verizon Prevailing Wage: The prevailing wage appeals board hearing of a Grievance with Verizon. The Executive Board discussed why the grievance was denied. Overall Verizon is reluctant to provide detailed benefit information requested by the appeals board.
- **B.** Labor Walk 9/14: District 2-13 Campaign Lead Bill Scott sent an email requesting volunteers for a joint District 1, 2-13 Labor Rally and Walk in West Philadelphia. The regions will begin soliciting volunteers. President Gardler will discuss with Campaign Lead Scott to provide more information.
- **C. District 2-13 Meeting:** District 2-13 will be holding the annual meeting in Valley Forge in the beginning of October. More details and an agenda will be provided soon.

## 7. The Arbitrations, Grievances, Mediation:

- A. Arbitration List: Local 13000 has no scheduled Arbitrations on the list provided.
- **B. Priority List:** Executive Vice President Reamer provided the Priority Arbitration List. The Board reviewed and updated the Priority List. Eastern Region Vice President Dezzi highlighted the importance of grievances in VonVital's organization (Verizon) regarding after hours work performed by contractors. Executive Vice President Reamer and Eastern Region Vice President Dezzi will coordinate with District Staff Representative to adjust the Priority List if necessary. Eastern Region Vice President Dezzi cleared the backlog of nonmeritorious grievances from years past. He highlighted Unit 33 OT equalization and OPT out of Title grievances that were moved to the District for Arbitration.
- **C. Fatigue Time Worked Grievances:** Western Region Vice President Bialek discussed issues at Verizon in Broggi's organization regarding FTW (Fatigue Time Worked) Grievances that were filed. At this time Labor relations are failing to provide the information requested. The board discussed options if the company continues this course.
- **D.** Artificial Intelligence doing BU work in FSC: Western Region Vice President Bialek reported that repair calls to the FSC were answered by Artificial Intelligence. The automated system provides subscribers with basic repair steps. These calls are calculated into the calls reported. Western Region Vice President Bialek asked that once the Units impacted collect the information, we present the issue to Senior Management or proceed with an expedited grievance.

- **A. Apple:** Secretary-Treasurer Smolczynski reported on the status of a campaign in an Apple retail location. The campaign has been ongoing for months and has seen an increase in support levels. The Organizing committee continues to meet weekly to review assessments and inoculation training. District 2-13 Organizing Coordinator Terry Garner has been assisting Secretary-Treasurer Smolczynski to help move the campaign forward.
- B. American Red Cross- Unit 111: Secretary-Treasurer Smolczynski and Western Region Vice President Bialek both reported that there has been interest from non-represented workers in the Johnstown work center. Unit 111 President Jaytricia Tremel the Coalition Bargaining Chair will begin the process to begin a formal Organizing Campaign notifying the Coalition Partner Unions. The next step in process will be Secretary-Treasurer Smolczynski notifying American Red Cross management of the CWA's intent to Organize per the National Addendum's neutrality language. Currently, we have interest in Hospital Services and Apheresis Departments. Weekly Organizing meetings with Western Region Vice President Bialek, Unit 111 President Tremel and workers from the proposed units have been informative and preliminary assessments have begun.
